This Vehicle is Equipped With

- Electric drive train, charging port and batteries.
- An industry approved curtain side body.
- Certified curtains. Refer to the certification plate mounted to the exterior of all curtains for individual ratings.
- · Load restraint points. Refer to the body or chassis certification plate for manufacturer load anchorage points and ratings.
- A tail lift platform. Refer to the load chart specific to the individual make and model located on the rear tail lift platform for the maximum rating.
- · A certified tow ball coupling and industry standard electrical socket. Refer to the draw beam mounted certification plate for the maximum rating.

Safety Advice Relating to this Vehicle

- Be aware of your operational working environment and look for hazards. Plan first, identify and asses all risks, eliminate or minimise the risk, continually monitor and review for improvement.
- · Always enter and exit the vehicle using multiple points of contact, use all available steps and grab handles.
- Always ensure the truck and trailer tow couplings are 100% compatible, and securely locked in place.
- Be cautious and take your time when working with moving items that could cause harm: E.g.: connecting units together, curtains, curtain tensioners, roof poles, load restraint devices, tool box latches and doors, tail lift platform.
- Never attempt to open the locked electrical component box. This is due to high voltage current inside.
- Never attempt to touch 'orange' electrical cable. This is due to high voltage current.
- Under no circumstances should you or others working around you ever place your body in a position underneath the tail lift when in raised position.
- Under no circumstances should you attempt to operate the vehicle on road with the tail lift platform in a lowered position.
- Check all operational items are secure, and all doors are closed before moving the vehicle.


Legal Details

- Class 2 driver's licence required at minimum to operate this vehicle.
- The maximum open road speed limit is 90 km per hour, the operator of this vehicle must comply under The Official NZ Road Code for Heavy Vehicle Drivers.
- Refer to the NZ Transport Agency Load Certificate displayed in the windscreen of the vehicle for the following information: Vehicle model, maximum permissible loadings in kilograms, vehicle tare weight, maximum towed mass (MTM), gross vehicle mass (GVM), gross combination mass (GCM), axle set ratings, axle spacings, wheelbase, heavy vehicle brake code (HVBC).
- Axle and vehicle loads must not exceed manufacturer's ratings, tyre capabilities, and all limits specified in the applicable Land Transport Vehicle Dimension
